FOREWORD

INTRODUCTION

This guide contains guidelines for using the current editions of IEC 60065 and IEC 60950-1 in evaluating the safety of multimedia equipment.

The following fundamental principle was adopted as the basis for this guide:

Equipment complying with the requirements of IEC 60065, as well as equipment complying with the requirements of IEC 60950-1, is considered to be safe when used on its own.

Such equipment when interconnected in multimedia systems in accordance with the installation instructions is also considered to be safe.

It should be noted that there are a number of differences between the two standards.

Requirements which should be fulfilled in addition to those in the current two standards are specified in this guide.

Additional clarifications are under consideration for both publications in IEC technical committee 108. Whenever IEC 60065 or IEC 60950-1 are amended or revised, or technical or market conditions change significantly, ACOS will consider this guide for revision.

For a multimedia system containing Class I and Class II equipment, the connection to the supply should ensure a reliable connection to protective earth for Class I equipment.

GUIDE ON THE SAFETY OF MULTIMEDIA EQUIPMENT

1 Scope

This guide contains guidelines for using the current editions of IEC 60065 and IEC 60950-1 in evaluating the safety of multimedia equipment.

3 Guidelines

3.1 Compliance

Equipment for use in multimedia systems should comply with

- IEC 60065 or IEC 60950-1, according to the manufacturer's choice; and
- the additions listed in this clause.

3.2 General requirements

IEC 60065, Clause 3: this clause is applicable.

IEC 60950-1, Subclause 1.3: no additions required.

3.3 Interfaces to the telecommunication network

IEC 60065: Annex B of IEC 60065 should be applied to equipment to which IEC 60065 is applied and which is intended for use in multimedia systems and for connection to a telecommunication network.

Alternatively, Clause 6 of IEC 60950-1 may be applied.

NOTE This choice applies to this item only and is permitted due to the fast evolution of the technology.
